- What form of advertisement of the consultation will take place.
- SPC would like to see that all residents in Southbourne are leaflet-dropped with the details.
- SPC would like to see a clear and in-plain-English summary of the consultation preferably in bullet point form.
- SPC would like to know the details by which CDC will be asking residents to respond to the Consultation.
- SPC would like to see that the details of the consultation describe clearly the three different proposals for development. Members felt that the sustainability appraisal did not clearly identify what the mixed proposal would mean for Southbourne.
